#### **EXPLANATION OF UNUSUAL COMPARATIVES:**

IF YOU WILL NOTICE, JANUARY 2023 SHOWS LESS GALLONS THAN JANUARY 2024, YET THE REVENUE FOR 2023 IS HIGHER. THE REASON FOR THIS IS DUE TO OVER/UNDER USAGE SBY PRESTAGE.

IN 2023 THEY USED **9,885,467 GALLONS UNDER** THE CONTRACTUAL AMOUNT THAT THEY PAY FOR. SO IN REALITY WE BILLED FOR 72,531,542 GALLONS EVEN THOUGH THAT IS WHAT NOT WAS USED. IN JANUARY 2024 THEY USED **3,247,233 GALLONS OVER WHAT** THEY PAY FOR SO WE ACTUALLY ONLY BILLED FOR 64,134,292 GALLONS- AS THEY ARE BILLED OVERAGES AT YEAR END.

SO -FOR A MORE REALISTIC COMPARATIVE ADJUSTED FOR PRESTAGE YOU WOULD LOOK AT BILLED GALLONS VERSUS USED GALLONS.
